



Internet Governance Forum 2024 | Regional Parliamentary Track alongside the AfIGF Parliamentarians' Contribution to Effective Data Governance on the African Continent

Concept note

CONTEXT

The <u>Internet Governance Forum</u> (IGF), convened annually by the UN Secretary-General, is a global multistakeholder platform that facilitates discussions on Internet and digital public policy issues. This year, the Kingdom of Saudi Arabia will host the United Nations 19th Internet Governance Forum (IGF 2024) under the overarching theme "Building our Multistakeholder Digital Future".

The <u>African IGF</u> (AfIGF) is a regional IGF initiative dedicated to fostering exchanges within the region on relevant digital policy topics. In recent years, the IGF has sought to strengthen the participation of parliamentarians in discussions on some of the most pressing issues related to the use, evolution and governance of the Internet and related digital technologies.

Building on Parliamentary Track experiences at the African IGF in 2022 and 2023, dedicated sessions for <u>parliamentarians from across the African region</u> is to be held again this year in Addis Ababa, Ethiopia, in the context of the 2024 AfIGF meeting. The overarching theme of the track is "*Parliamentarians' Contribution to Effective Data Governance on the African Continent*". The Track will be attended by 14 Members of Parliaments from various African countries and the Ethiopian Parliament will be invited to join the sessions.

DESCRIPTION

The activities will facilitate dialogue and exchanges on key digital policy issues among Members of Parliaments (MPs), and between MPs and other stakeholders from within and beyond the African continent. Focus will be given to the Parliamentarians of information and communication technology (ICT) related committees at the national or regional parliaments, who work on digital affairs and Internet policy issues.

Objectives

- Familiarize MPs with the IGF space and the broader international ecosystem for Internet governance and digital policy. Encourage them to actively contribute to relevant regional and international processes.
- Prepare MPs for participation in the IGF 2024 meeting and the dedicated Parliamentary Track, as well as future IGF meetings and activities.
- Update MPs on a set of Internet governance and digital policy issues relevant to African countries. Facilitate dialogue on these issues with other parliamentarians, as well as with relevant international and regional organisations from different stakeholder groups (intergovernmental organisations, the technical community, private sector, civil society).





- Discuss the relevance of legislative work in shaping a digital future in the region. Highlight issues that need to be considered when legislation for the digital space is developed.
- Facilitate cooperation and exchanges of good practices with MPs from national and regional parliaments, as well as parliaments from other regions, which have advanced legislative work on digital policy issues.
- Expose the MPs to relevant internet governance processes (e.g., the Global Digital Compact, WSIS+20 review) and other UN flagship initiatives.

Collaborators

• The IGF Secretariat is collaborating on the regional Parliamentary Track with several partners, including the UN Economic Commission for Africa (UNECA), the Africa IGF Secretariat, the African Union, the GIZ, the African School on Internet Governance (AfriSIG), and the African Parliamentary Network on Internet Governance (APNIG).

OUTPUT

Parliamentarians from the region are invited to discuss the proposed issues with experts, share their views, explore the questions at hand, and exchange opinions and experience on existing or potential legislative solutions.

The key messages that emerge from the regional Parliamentary Track exchanges will be captured as the formal, action oriented regional IGF 2024 Parliamentary Track output. The regional perspectives will also be communicated in the activities of the annual IGF Parliamentary Track, to be held in December 2024 in Riyadh, Kingdom of Saudi Arabia.

FORMAT AND PROGRAMME

The Parliamentary Track at the regional IGF will include:

- Sessions dedicated to Members of Parliaments from 20 to 21 November, including a session in collaboration with the African School on Internet Governance.
- A dedicated session between Members of Parliaments and the African Youth on 21 November.
- The participation of MPs in other sessions of the AfIGF on 21 and 22 November.

20 November 2024	[Parliamentary Session 2] The Impact of Artificial Intelligence on Democracy, Human Rights and the Rule of Law
11:30 - 13:00 local time Africa Hall	Through their legislative, oversight and representative functions, parliaments have a key role with regards to digital policymaking in the governance of digital. In October 2024, the resolution "The impact of artificial intelligence on democracy, human rights and the rule of law" was unanimously adopted by the 149 th Inter-Parliamentary Union Assembly in Geneva. Before introducing the first-of-a-kind resolution by one of the co-rapporteurs of the text and Tanzanian Member of Parliament, Neema Lugangira, UNESCO will set the scene by presenting emerging approaches of Artificial Intelligence regulation across the world. This consultation paper was developed through discussions with Members of Parliaments in the lead up to the IPU resolution on AI, as well as through capacity building workshops and webinars organized by the IPU, UNESCO and the IGF earlier in 2024.
