## Internet Governance Forum 2025 | Parliamentary Track

### *Building Digital Governance Together*

#### PROGRAMME

#### CONTEXT

---

As a multi-stakeholder platform, the United Nations Internet Governance Forum (IGF) brings together over 10,000 participants each year, facilitating the discussion of public policy issues pertaining to digital technologies on and off the internet.

This year, Norway is hosting the [20th Internet Governance Forum](#) (IGF 2025), to be held on **23–27 June 2025 in Lillestrøm** under the overarching theme *Building Digital Governance Together*. With over 100 scheduled sessions, the programme will be structured around the following four sub-themes:

- [Building] Digital Trust and Resilience
- [Building] Sustainable and Responsible Innovation
- [Building] Universal Access and Digital Rights
- [Building] Digital Cooperation

Since 2019, the IGF has actively involved MPs from around the world, providing an important platform for exchanging views and strengthening digital cooperation both within the parliamentary community and with representatives from the private sector, the technical community and civil society, including youth and academia. Through a dedicated Parliamentary Track, and in collaboration with numerous IGF partners, the Forum organizes a set of activities in the lead-up to and at the annual IGF meeting.

The Parliamentary Track at IGF 2025 takes place on 23–25 June. It is jointly organized by the IGF Secretariat, which is hosted within the UN Department of Economic and Social Affairs, by the Inter-Parliamentary Union (IPU) and by the host country's parliament, in this case the Parliament of Norway (the Storting). The IGF welcomes the participation of all interested MPs and parliamentary staff, especially those working in relevant parliamentary committees or on digital affairs and internet policy issues.

#### TOPICAL OVERVIEW OF THE PARLIAMENTARY TRACK

---

Under the overarching theme *Building Digital Governance Together*, the Parliamentary Track at IGF 2025 will explore the development and implementation of digital public policies that aim to counter online mis- and disinformation while upholding the fundamental right to freedom of expression. With a particular focus on safeguarding vulnerable groups, especially children, the discussions will examine regulatory approaches, platform accountability and the balance between content moderation and democratic freedoms. MPs will engage with experts to consider innovative, rights-based frameworks that promote a safer, more inclusive digital environment.



The Parliamentary Track sessions will be interactive and engaging, providing numerous opportunities for MPs to hear from, and share their perspectives with, participating stakeholders and fellow parliamentarians.

In summary, the Parliamentary Track at IGF 2025 will pursue the following aims:

- Build on the outcomes of the Parliamentary Track at IGF 2024
- Foster rich conversations through multi-stakeholder panels
- Identify parliamentary priorities and ways to build capacity and take action on these priorities

## OUTPUT

---

The key messages that emerge from the Parliamentary Track discussions will be captured in an action-oriented document that will serve as one of the formal outputs of IGF 2025.

The Parliamentary Track output document will be circulated to all parliaments and incorporated into the IGF summary report, which will inform UN Member States and IGF stakeholders.
